REPORTABLE WINNINGS

REPORTABLE WINNINGS ARE THOSE WINNINGS THAT WERE REPORTED TO THE INTERNAL REVENUE SERVICE BY COMPLETING A W2G, STATEMENT OF EARNINGS FROM GAMING. THE REPORTS TO THE IRS ARE REQUIRED BY LAW. REPORTABLE WINNINGS ARE NOT ALL WINNINGS WHICH ARE REQUIRED BY TAX LAW TO BE CLAIMED AS EARNINGS.

WINNINGS

WINNINGS ARE ALL YOUR WINNINGS PAID OUT FROM SLOTS, TABLE GAMES OR OTHER GAMES. THESE ARE REQUIRED TO BE CLAIMED AS GAMBLING EARNINGS ON YOUR TAX RETURN AND INCLUDE THOSE 'REPORTABLE WINNINGS' DESCRIBED ABOVE.

WIN LOSS STATEMENTS MAY NOT REFLECT ACTUAL GAMING RESULTS AT MORONGO

THESE STATEMENTS ARE PLAYERS RATING STATEMENTS AND NOT TAX DOCUMENTS. IF THE PLAYER DID NOT USE THE WINNERS CLUB CARD NO RECORD IS KEPT. EACH DAYS WIN LOSS IS A NET OF THE WINS AND LOSSES FOR THAT DAY (LUMPED). FOR THE PURPOSE OF TAX DEDUCTIONS, EACH PLAYER MUST MAINTAIN OTHER RECORDS. THE PATRON'S DIARY OF WAGERS AND WINS, BY DATE AND TIME, AND NAME AND ADDRESS OF GAMING FACILITY, NAMES OF OTHER PERSONS PRESENT, AND OTHER RECORDS (CANCELED CHECKS, CREDIT CARD RECORDS, ATM RECORDS, BANK WITHDRAWALS, AND OTHER RECEIPTS WILL BE OF ASSISTANCE TO ITEMIZE LOSSES AND DOCUMENT SUCH LOSSES FOR TAX DEDUCTIONS PLANNED TO BE CLAIMED.
